While Excise department have seized **1295.75** litres of IML & other liquor worth Rs. **4,91,103.75** and booked 51 Heinous cases, 68 cases for Breach of Licence conditions and 367 cases under Section 15 (a) of Karnataka Excise act 1965 in last 24 hours. Cumulatively, **515903.367** litres of IML & other liquor worth **Rs. 23,90,13,337.75/-** and booked **2244** Heinous cases, **2357** cases for Breach of Licence Conditions, **03** NDPScase and **7539** cases under Section 15 (a) of Karnataka Excise act 1965.And also 951 different types of Vehicles have been seized.

#### **LAW & ORDER:**

83 persons were bounded over under preventive sections of CRPC, and 31 Non-bailable warrants were executed, preventive sections of CRPC booked in 51 cases,864 Nakas made operational in the last 24 hours. Cumulatively, 71574 arms have been got deposited since the date of enforcement of Model Code of Conduct and out of total 97,043 arms 97,031 arms have been deposited till date,52 arms were impounded, 6 armed licenses have been cancelled, preventive sections of CRPC are booked in **17949** cases since the date of enforcement of MCC and total 49,427 preventive section under CRPC cases have been put up from 01.01.2018 till date, **23447** persons were bounded over under preventive sections of CRPC and **38456** Non-bailable warrants were executed from the date of enforcement of elections.
